## **RESCISSION OF ADOPTION – MCL 710.66 - PROCEDURES** (Only applies to Stepparent Adoptions after Adoptee is an Adult)

- The birth parent, whose rights were terminated at the time of the adoption, must agree to be reinstated as the parent.
- Adoptee and biological parent whose rights were terminated complete **PCA 349 Petition for Rescission** of Adoption and Order. Both the adoptee and birth parent must sign the petition.
- All required paperwork is filed with the Adoption Department of this court.
- File the following:
  - One copy of PCA 349 Petition for Rescission of Adoption and Order, with original signatures
  - One copy of the adoptees current legal birth certificate (the one created after the adoption). This does not have to be a certified copy.
  - Copy of adoptee and birth parent's ID
  - Check or money order for **\$20 made out to the 17<sup>th</sup> Circuit Court-Family Division**

- A judge will be assigned to the case, and a hearing will be set before a judge or referee of this court. The petitioners (adoptee and birth parent-if available) shall attend the hearing. Notice of the hearing will be sent to the adoptive stepparent and the birth parent whose rights were not terminated at the time of the adoption. They are considered interested parties regarding a rescission petition.
- In addition to the hearing, the court may order an investigation by an employee or agent of the court.
- The court may rescind the adoption and restore the parental rights of the birth parent, or the court may deny the petition.
- If the adoption is rescinded, the adoptee will become an heir at law of the birth parent whose parental rights are restored and will no longer be an heir at law of the prior adoptive parent. The adoptee will remain an heir at law of the biological parent whose rights were not terminated at the time of the adoption.
- If the adoption is rescinded, the court will notify the vital records department in the state where the adoptee was born that the adoption has been rescinded. The vital records office will reinstate the original birth certificate. In Michigan, the fee for a copy of a reinstated original birth certificate would be \$34. Fees in other states will vary. If the adoptee would like a copy of the original birth certificate, they should provide the court with a check or money order made out to the State of Michigan for \$34. Additional copies ordered at the same time are \$16 each.
