The Kent County Drain Commissioner will meet on the above date, time and location to receive construction bids for the Walker No. 4 Drain. Bids will then be opened and publicly announced.

The Walker No. 4 Drain project will be let in one section as follows, each section having the length, average depth and width as set forth: *Proposed work is approximately 1 miles of open channel cleanout, with an average depth of 5-feet and average bottom width of 3-feet.*

This Notice of Letting, the plans, specifications and bid proposal shall be considered a part of the Contract. The Contract will be let in accordance with the Contract Documents now on file at Kent County Drain Commissioner’s Office and available to interested parties. Bids will be made and received in accordance with these documents. The Contract will be awarded to the lowest responsive and responsible bidder giving adequate security for the performance of the work. The Contract completion date and the terms of payment will be announced at the time and place of letting. If no satisfactory bids are received, we reserve the right to reject any and all bids and to adjourn to a time and location as we shall announce.

The following is a description of the several tracts or parcels of lands constituting the Special Assessment District of the Walker No. 4 Drain, as well as a list of any county, township, city, village to be assessed at large:

- Section 5, T6N, R12W – The West ½ of the Northwest 1/4
- Section 6, T6N, R12W – The North ½ of the SE ¼ and the North ½
- Section 30, T7N, R12W – The East ½ of the Southeast ¼ and the South ¾ of the Southwest 1/4
- Section 31, T7N, R12W – The Southeast ¼, the Southwest ¼, the Northwest ¼, and the East ½ of the Northeast 1/4
- Section 32, T7N, R12W – The West ½ of the Southwest ¼
