The signers of this petition further request that the drainage district be extended into Montcalm County to include lands lying within Sections 20, 21, 28, 29, 30, 31, 32 and 33 of Pierson Township, pursuant to Section 135. The maintenance and improvement is necessary to alleviate flooding in the vicinity of Sand Lake.

This petition is signed by at least five (5) freeholders whose lands shall be liable for assessment for benefits of the work requested.

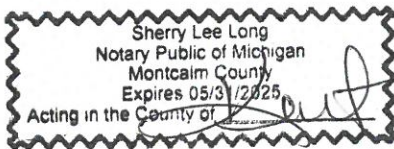
