### 9. Report of the Director:

Gustavo shared that he recently presented the department's performance measures report to the Board of Commissioners. He emphasized the work of the Housing Commission and its impact in our community. He also shared client stories to personalize the data and show the difference this program makes in people's lives. Since the presentation, we have received positive feedback from the Administrative Staff and Board of Commissioners. As part of the department's efforts to improve how we share our data we are working with a group of University of Michigan students to create a data dashboard. This dashboard will visualize the impact KCCA makes within the community, and we will be able to see the demographics of who we are serving in which areas of the county. This is

a two-semester long project so the dashboard should be operational around the spring of 2024. Gustavo informed the commissioners that we did decide to step away from Happy software. The vendor was not willing to negotiate the language of the contract, which included unfavorable terms for the department. Jen Kozlowski is working on putting together the RFP that will be going out soon to fulfill our software needs. In other news, HUD recently notified us that we are getting 14 additional HUD VASH vouchers. There are a total of 28 for our area and we received half of those thanks to the advocacy work of Emily. Lastly, Gustavo shared that we have received high praise from landlords and the community about our staff. They go above and beyond for our clients and are a pleasure to work with.

## 10. Financial Report:

Brenna was happy to share that we were finally reimbursed for the FSS grant. On the first line of the financial report, there is now an amount. It took longer than we would have liked to do the draw because over a certain amount we need HUD approval.
