 Corewell Health, Priority Health, Pine Rest, and the Kent County Health Department partnered to host another DEA Drug Take Back Day at three different locations in Kent County. In total, 281 pounds of medication were collected and 57 boxes of Narcan were distributed to community members.

### Intervention Updates – Steve Alsum, Grand Rapids Red Project

- The subcommittee has drafted a slide deck for the community dialogue sessions, which they are hoping to schedule with colleges for the winter 2023 semester. The KCOTF took 10 minutes during the meeting to answer the following questions via a Qualtrics survey:
  - Would you be interested in being on the teaching team?
  - What is the greatest need from your perspective?
  - How has the community met or partially met that need?
  - What are the current barriers that prevent meeting that need?
- The answers from these questions will be used to inform the slides and community dialogue.

- Leadership Updates Rachel Jantz, Kent County Health Dept.
  - o No updates yet on the distribution of opioid settlement funds in Kent County.
  - o All subcommittees are currently working on developing their 2023 A3s.
- Kent County Data Report Rachel Jantz, Kent County Health Dept.
  - Per the most recent data from the medical examiner, there have been 63 opioid-involved fatalities in Kent County in 2022. Fentanyl was involved in 94% of these deaths. In 2021, the opioid overdose fatality rate was 41.8 per 100,000 for black residents, which is 4.2 times greater than the rate for white residents.
