DESCRIPTION OF INCIDENT:

On 06-10-2018 at approximately 1519hrs Pamela Edmisten was operating a 1999 Toyota S/B on Lincoln Lake south of 5 Mile. At this time it's believed she stationed her car on the east shoulder of the road and attempted to make a U-turn to N/B Lincoln Lake. She was struck by vehicle #2, a 1995 Ford Bus/motorhome, that was traveling S/B. Edmisten died of her injuries sustained in the crash. The driver and passengers in #2 were not injured.
